# Terms and Conditions of Hire of 'Cornwall Marquee Venue'

## 1. PERIOD OF HIRE.

The period of hire is understood to mean the period during which the field is hired. All Marquees may be erected two days prior to the event, but must be taken down the day after the event.

## 2. SITE CONDITION

Cornwall Marquee Venue agrees to provide during the period of hire a field in good order with grass mown.

## 3. CAMPING:

Any person camping (and such term is to include the use of motor homes and like vehicles) in the field must pay in advance per 'Cornwall Marquee Venue' Price List and must vacate the property by 12pm on the day after the event. All rubbish and personal belongings must be removed.

## 4. PARKING:

Any person leaving their vehicle parked on the site, do so at their own risk. 'Cornwall Marquee Venue' cannot be held responsible for any damage caused whilst on site howsoever caused

## 5. REFUSE:

The hirer will be responsible for the removal of all refuse and will leave the field clean and tidy within the period of hire. Cornwall Marquee Venue reserves the right to charge the cost of clearing rubbish in the event that this is not completed by the Hirer and the cost of such clearing will be payable by the Hirer within 7 days of receipt of an invoice for the work completed.

## 6. MUSIC:

Music must be tuned off at midnight.

## 7. HIRE CHARGES.

Other than the site hire, any hire charges published in any 'Cornwall Marquee Venue' information are for guidance only and do not constitute an offer.

## 8. PAYMENT.

'Cornwall Marquee Venue' reserves the right to charge a non refundable deposit of 50% of the final figure to confirm the booking. The balance will be payable 6 months prior to the event. All prices are subject to 6% damage waiver surcharge. Please make all cheques payable to A.D.G. Eyles.

## 9. LOSS OR DAMAGE.

The Hirer is wholly responsible for all equipment on hire from the time of delivery until collection and they will make good any damage to the 'Cornwall Marquee Venue' property. Overnight security is not the responsibility of 'Cornwall Marquee Venue' and is at the risk of the Hirer

## 10. INSURANCE.

'Cornwall Marquee Venue', has insured the field against most forms of accidental damage for which the Hirer is responsible for the first £250 of each and every claim. The terms are available for inspection at all reasonable times and the Hirer will be deemed to have seen and agreed these and will abide by their conditions.

## 11. LIABILITY TO THIRD PARTIES.

'Cornwall Marquee Venue' will not be responsible for any injury to persons or loss of or damage to property howsoever caused.

## 12. PERMITS.

The Hirer is responsible for giving notice to or obtaining all necessary permits from any authorities who are or may be concerned and must make application where to the Planning Authority, District Surveyor, Police, Fire Brigade, and any similar authority or organisation and shall comply in all respects and at their own cost all conditions imposed in respect of same and will indemnify Cornwall Marquee Venue from and against each and every claim made against it at any time in respect of the period of hire as owner/licensee of the land.

## 13. FORCE MAJEURE.

While every effort will be made by 'Cornwall Marquee Venue' to provide the field for hire, it is subject to variation or cancellation by Cornwall Marquee Venue, consequent upon act of God, War, Strikes, Riots, Lock-outs or other labour disturbances, Fire, Flood, restrictions in the use of Transport, Fuel or Power, Requisitioning, Shortage of Material or Transport or Labour or any other cause beyond the control of Cornwall Marquee Venue.

## 14. MODIFICATION OF CONTRACT.

No verbal representations or arrangements are recognised by the Company and these terms and conditions shall only be modified by a supplementary written contract.

## 15. CANCELLATION OR PREMATURE TERMINATION OF CONTRACT.

In the event of the Hirer cancels the contract after a firm order has been placed the following charges will apply:

More than 6 months prior to the event, half the 50% deposit will be refunded by Cornwall Marquee Venue within 4 weeks of the date of cancellation.

Between 3-6 months before the event, the 50% deposit will not be refunded, but should the final payment have been paid at this juncture then it will be refunded by Cornwall Marquee Venue within 4 weeks of the date of cancellation.

Within 3 months of the event full hire charges will be required.

The Hirer will be responsible for insuring themselves against cancellation fees should they so require.

## 16. ACCESS.

Access to the site will be over such route as Cornish Marquee Venue shall decide.

## 17. LIGHTING

Lighting shall be supplied by the Hirer as needed but shall be subject to direction by Cornish Marquee Venue but only to prevent a nuisance or giving annoyance to nearby guests, visitors and residents.

## 18. GLASS

Glasses and bottles shall not be taken outside any marquee
